A. Superintendent's Report

- Soccer had good year, lost 1st round of playoffs but had a great year overall. Great job by Coach Lomas and Assistant Coach Roche.
- Winter sports physicals and tryouts have begun. Should have final team listings by the end of the month.
- Chestnut Ave parking ordinance is up for final vote tonight. We have been working to get notice out to the public. Effective in December you can only park on the school side of Chestnut during drop off/pick up hours.
- Café projects started yesterday. New garage door to facilitate storage use of sea chest, also stage notch to allow additional room for the electronic basketball net to be raised.
- Tailgate Party and Halloween Parade last week to celebrate end of 4th marking period last year. All had great time.
- Nov 23 is the renaissance pep rally to celebrate 1st marking period achievements.

B. Business Administrator's Report

- I've been compiling data for DRTRS and ASSA reports due November 18th and December 2nd respectively.
- Completed the Comprehensive Maintenance Plan which is on the agenda for approval. It is on schedule to be submitted to the county by the November 15th due date.

NOW, THEREFORE, BE IT RESOLVED that the Somerdale Park Public School District, Board of Education will go into closed session for the following reason(s) as outlined in N.J.S.A. 10:4-12(b): _Any matter which, by express provision of Federal Law, State Statute or Rule of Court shall be rendered confidential or excluded from discussion in public Any matter in which the release of information would impair a right to receive funds from the federal government; Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publically; Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed; Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection; Any investigations of violations or possible violations of the law; Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party.
