On a motion made by Mrs. Moore and seconded by Mr. Walsh the board entered into executive session at 7:07 pm

WHEREAS, while the Sen. Byron M. Baer Open Public Meetings Act (N.J.S.A. 10:4-12 et seq.) requires all meetings of the Somerdale Park School District, Board of Education to be held in public, N.J.S.A. 10:4-12(b) sets forth nine types of matters that may lawfully be discussed in Executive Session," i.e. without the public being permitted to attend; and

WHEREAS, the Somerdale Park Public School District, Board of Education has deemed it necessary to go into closed session to discuss certain matters which are exempted from the Public; and

WHEREAS, the nine exceptions to public meetings set forth in N.J.S.A. 10:4-12(b) are listed below, and next to each exception is a box within which the number of issues to be privately discussed that fall within that exception shall be written, and after each exception is a space where additional information that will disclose as much information about the decision as possible without undermining the purpose of the exception shall be written.

NOW, THEREFORE, BE IT RESOLVED that the Somerdale Park Public School District, Board of Education will go into closed session for the following reason(s) as outlined in N.J.S.A. 10:4-12(b):

X Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed in public;

WHEREAS, the length of the Executive Session is undetermined; however, the Somerdale Park Public School District, Board of Education will make every attempt to estimate the time of the session prior to convening the session after which the public meeting shall reconvene at approximately 7:47 pm and the Somerdale Park Public School District, Board of Education will proceed with business.

NOW, THEREFORE, BE IT RESOLVED, that the Somerdale Park Public School District, Board of Education will go into Executive Session for only the above stated reasons;

BE IT FURTHER RESOLVED that the Somerdale Park Public School District, Board of Education hereby declares that its discussion of the aforementioned subject(s) may be made public at a time when the Somerdale Park Public School District, Board of Education attorney advises that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the school district or any other entity with respect to said discussion.

BE IT FURTHER RESOLVED that the Somerdale Park Public School District, Board of Education, for the aforementioned reasons, hereby declares that the public is excluded from the portion of the meeting during which the above discussion shall take place and hereby directs the board secretary to take the appropriate action to effectuate the terms of this resolution.

RESOLUTION

SOMERDALE BOARD OF EDUCATION RESOLUTION AUTHORIZING APPROVAL OF ADJUSTMENT TO THE SUPERINTENDENT'S CONTRACT PURSUANT TO THE CONTRACT'S EXISTING TERMS AND CONDITIONS

WHEREAS, the Somerdale Board of Education ("SBOE" and/or "Board") entered into an Employment Contract dated February 17, 2016 with Dr. Dennis M. Vespe ("Vespe") to serve in the position of Superintendent; and

WHEREAS, the Employment Contract contains a provision setting forth the annual salary in the amount of \$135,000.00 in each year of the contract; and

WHEREAS, the Employment Contract further contains a provision allowing the Board and Vespe to select up to three (3) quantitative merit criteria and up to two (2) qualitative merit criteria per contract year and provides that Vespe shall receive a merit bonus in an amount up to 3.33% of his annual base salary for each

quantitative merit criterion achieved and/or a merit bonus in an amount up to 2.5% of annual base salary for each qualitative merit criterion achieved; and

WHEREAS, Article IV(A)(1)(a) of the Employment Contract provides that should the existing law that caps the Superintendent's salary sunset, the merit pay component shall become part of Vespe's salary and there shall no longer be any entitlement to merit bonuses, thereby increasing the annual salary amount to \$155,236.50; and

WHEREAS, the existing law that caps superintendent's salary did sunset, with new provisions becoming effective May 1, 2017 as codified in N.J.A.C. 6A:23A-1.2; and

WHEREAS, N.J.A.C. 6A:23A-1.2 allows for the maximum salary amount for a superintendent of any school district with a total enrollment of 749 or less, such as the Somerdale School District, to be \$147,794.00, with the ability to exceed the maximum salary amount by two (2) percent in any year of the contract, along with an additional administrative position salary increment in the amount of \$5,000; and

WHEREAS, as Vespe serves in an additional administrative position, he is entitled to the additional administrative position salary increment and therefore the provisions of the law do allow for the increase of Vespe's salary to the amount of \$155,236.50, pursuant to the terms and conditions of the existing Employment Contract; and

WHEREAS, the Board desires to formally acknowledge and memorialize the existing terms and conditions of the Employment Contract, specifically Article IV(A)(1)(a), in light of the change of maximum salary amount as codified in N.J.A.C. 6A:23A-1.2, while making no changes to the existing terms and conditions of the Employment Contract.

NOW, THEREFORE, BE IT RESOLVED, by the Somerdale Board of Education as follows:

- **1.** The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
- 2. Pursuant to Article IV(A)(1)(a) of the Employment Contract between the Somerdale Board of Education and Dr. Dennis M. Vespe and the provisions of N.J.A.C. 6A:23A-1.2, the annual salary for Dr. Dennis M. Vespe shall be \$155,236.20, effective July 1, 2017 for the duration of his existing Employment Contract with the Somerdale Board of Education.
- **3.** Pursuant to Article IV(A)(1)(a) of the Employment Contract between the Somerdale Board of Education and Dr. Dennis M. Vespe and the provisions of N.J.A.C. 6A:23A-1.2, Dr. Dennis M. Vespe will no longer be eligible for any merit pay for the duration of his existing Employment Contract with the Somerdale Board of Education.
- **4.** The SBOE's Superintendent, Business Administrator, Board President and/or Board Vice President or their designees are hereby authorized to take any and all action required to effectuate the provisions of the contract.
