VI. REPORTS

A. Superintendent's Report

• Curriculum and Instruction

- a) At our Teacher-in- Service on January 12th I went over with the staff our School Performance Report Summary and the teachers worked in groups to discuss topics for our PLCs that provides time to analyze state test results, MAP test results, and ways to further address the students' achievement gap. The full NJ Performance Report is available for review on our website under the "Public" tab.
- b) Melissa Engelhardt and I met with the County Superintendent and other D.O.E. representatives for our Mid-Year Review on January 16th at the County Office in Blackwood. Budget items were reviewed and discussed.
- c) I met with the Board's Curriculum Committee on Thursday, January 18, 2018. Items discussed and reviewed were: NJ School Performance Report Summary, proposed School Calendar for 2018-2019, Possible change in the middle school schedule for next year to provide for fine arts and other cycle courses being brought back for 2018-2019 school year, and proposed job descriptions.
- d) There is change in the state test for science schedule. This year our 5th grade students will be tested in science instead of the 4th grade. This testing will take place on May 23-25 for 8th grade and May 30- June 1 for 5th grade.
- e) On January 23rd 50 of our 8th grade students took Sterling High School's honors testing.
- f) The D.O.E. QSAC Review team visited our school and spent the day monitoring our progress in addressing the District's Improvement Plan and debriefing me on the preliminary findings and recommendations. A formal report will follow later that I will share with the Board. Most of their recommendations centered around the loss of points on the QSAC DPR for poor student achievement scores on the state test and our World Language program for grades K-3. I shared with them want we are doing to address these areas

School Bond

Melissa Engelhardt and I met with the School Bond Committee on January 17th. Discussions centered around submitting a one question bond proposal to the D.O.E. for approval and possibly going out for a bond vote this fall.

• Budgeting for 2018-2019:

Melissa Engelhardt and I met with the Board's Finance Committee on February 1st. We went over the proposed budget for 2018-2019, when state aid figures will be released, and the local tax impact.

School Safety and Security

- a) The School's Safety Committee met on January 18th to review the school's safety manual.
- b) Mr. Ford and I went over revised "Lock Down" procedures and we conducted a "Lock Down" drill on January 31st. Officer Smith was present and observed how this drill was carried out.

- Our staff and students are to be commended for how well they executed the "Lock Down" procedures.
- c) I sent a letter to our parents/guardians about the passing of Dante Smith a teaching aid and the "Lock Down" drill on January 31.
- d) Chief Campbell and I met on January 19th to review the Memorandum of Understanding between the Somerdale Police and our school. We also went outside to discuss traffic flow concerns
- e) I attend the MOU signing workshop at the county office on January 25.

• Winter Sports:

Our Boys' and Girls' Basketball teams had very successful seasons. currently we are 9-3 (league record), and 12-3 (overall). If we beat Brooklawn tomorrow, it will be our 3rd consecutive Divisional title for the boys and the first title for our girls. In addition, Coach Still's career win number is 112. Go Cavs!

Recognitions and Awards:

- a. Our annual DARE graduation was held on January 24 in the cafeteria. Mayor Passanante was the guest speaker. Chief Campbell, Deputy Chief Walsh, and several police officers attended. Patrolman Alex Keister presented the essay awards and certificates of completion to our 5th grade students. There were several parents in attendance.
- b. There were 28 students who had all "A"s and made the Superintendent's List for the second marking period. We had 93 students who made the Principal's List for the second marking period. There will be a Superintendent's List Breakfast on February 14th at 8:30 AM in the cafeteria to honor our students who made the Superintendent's List. I would like to invite our B.O.E. members to this event.
- c. There are 131 students who earned Renaissance Cards in grades 5-8 for the 2nd marking period. For grades K-2 147 students will be attending the Glow Stick Party on Friday, February 16th. There was a total of 278 students who earned Renaissance recognition for the second marking period.
- d. Yesterday, Our middle school was recognized at our faculty meeting for being selected for the Camden County Middle Character Award. There was a nice presentation by the committee who selected our school for this honor and we were awarded \$500 for being selected. This money will go towards supporting our Renaissance program.

WHEREAS, the Somerdale Board of Education ("SBOE" and/or "Board") has entered into an Interlocal Services Agreement with the Borough of Somerdale to provide custodial and building and grounds services for Somerdale Park School; and

Baer Open Public Meetings Act (N.J.S.A. 10:4-12 et seq.) requires all meetings of the Somerdale Park School District, Board of Education to be held in public, N.J.S.A. 10:4-12(b) sets forth nine types of matters that may lawfully be discussed in Executive Session," i.e. without the public being permitted to attend; and

WHEREAS, the Somerdale Park Public School District, Board of Education has deemed it necessary to go

into closed session to discuss certain matters which are exempted from the Public; and

WHEREAS, the nine exceptions to public meetings set forth in N.J.S.A. 10:4-12(b) are listed below, and next to each exception is a box within which the number of issues to be privately discussed that fall within that exception shall be written, and after each exception is a space where additional information that will disclose as much information about the decision as possible without undermining the purpose of the exception shall be written.

NOW, THEREFORE, BE IT RESOLVED that the Somerdale Park Public School District, Board of Education will go into closed session for the following reason(s) as outlined in N.J.S.A. 10:4-12(b):

X Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed in public;

WHEREAS, the length of the Executive Session is undetermined; however, the Somerdale Park Public School District, Board of Education will make every attempt to estimate the time of the session prior to convening the session after which the public meeting shall reconvene at 8:30 pm and the Somerdale Park Public School District, Board of Education will proceed with business.

NOW, THEREFORE, BE IT RESOLVED, that the Somerdale Park Public School District, Board of Education will go into Executive Session for only the above stated reasons;

BE IT FURTHER RESOLVED that the Somerdale Park Public School District, Board of Education hereby declares that its discussion of the aforementioned subject(s) may be made public at a time when the Somerdale Park Public School District, Board of Education attorney advises that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the school district or any other entity with respect to said discussion.

BE IT FURTHER RESOLVED that the Somerdale Park Public School District, Board of Education, for the aforementioned reasons, hereby declares that the public is excluded from the portion of the meeting during which the above discussion shall take place and hereby directs the board secretary to take the appropriate action to effectuate the terms of this resolution.

BE IT FURTHER RESOLVED that the Board Secretary on the next business day following this meeting, shall furnish a copy of this resolution to any member of the public who requests one at the fees allowed by N.J.S.A. 47:1A-1 et seq.

XIII. RETURN TO PUBLIC SESSION

On a motion made by Mr. Anderson and seconded by Mrs. Moore the board returned to public session at 9:12 pm

XIV. ADJOURNMENT
