Somerdale School District will be participating with the New Jersey Partnership for Student Success (NJPSS) to leverage volunteers and community organizations to help students, educators, and schools recover from the COVID-19 pandemic. After hundreds of individuals and organizations expressed interest, and described the talents and skills they can offer, the New Jersey Department of Education (Department) is seeking to match volunteers with local schools and districts seeking supports. 4. Finally, I would like to begin discussions on the recommendation of naming the basketball court in our gymnasium after Michael Kidd- Gilchrest. For those who are not familiar with Michael, he is a graduate of Somerdale Park School where he first displayed his talent with basketball. In April 2012, Kidd-Gilchrist declared for the 2012 NBA draft. On June 28, he was drafted second overall by the Charlotte Bobcats.

On July 7, 2012, the Bobcats signed Kidd-Gilchrist to a rookie scale contract.

On November 10, 2012, in just his fifth NBA game, Kidd-Gilchrist had 25 points and 12 rebounds in a 101–97 win over the Dallas Mavericks, marking Charlotte's first ever win over Dallas in the franchise's nine-year history, ending a 16-game losing streak against the Mavericks.--He had a second 25-point, 12-rebound effort on December 19, 2012 against the Phoenix Suns.--He became only the second player in NBA history to post two games with at least 25 points and at least 12 rebounds before his 20th birthday and became just the fourth player in 20 years to record two such games in the first 25 games of his career.--On April 5, 2013, he had a season-high 14 rebounds against the Miami Heat.--On May 14, 2013, he was named to the NBA All-Rookie Second Team.

## RESOLUTION OF THE SOMERDALE BOARD OF EDUCATION AUTHORIZING THE EXECUTION OF AN ADDENDUM TO THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE SOMERDALE BOARD OF EDUCATION AND THE SOMERDALE EDUCATION ASSOCIATION

WHEREAS, the Somerdale Board of Education ("SBOE") and the Somerdale Education Association ("SEA") are parties to an existing Collective Bargaining Agreement which commenced on July 1, 2022 through June 30, 2025 ("Agreement"); and

WHEREAS, following the execution and commencement of the Agreement, the parties desired to add additional extracurricular activities; and

WHEREAS, the Parties negotiated the stipends for the additional extracurricular activities in the form of an Addendum to the Agreement which is attached to and made a part hereof, the terms of which shall be incorporated into the successor Collective Bargaining Agreement between the Parties.

NOW, THEREFORE, BE IT RESOLVED, by the Somerdale Board of Education as follows:

# APPLICANT'S RESOLUTION LEAP IMPLEMENTATION GRANT

WHEREAS, the State of New Jersey has appropriated \$10 million for Shared Services and School District Consolidation Study and Implementation Grants to assist local units with the study, development, and implementation of new shared and regional services; and

WHEREAS, the Department of Community Affairs, Division of Local Government Services (DLGS) is tasked with administering these grant funds through the Local Efficiency Achievement Program (LEAP); and

WHEREAS, \$2 million in LEAP Implementation Grant funds has been set allocated to support costs associated with school district consolidation studies; and

WHEREAS, the Boards of Education of the Somerdale, Magnolia Stratford and Laurel Springs school districts (collectively the "Sending District Boards of Education") have determined to evaluate whether the sending district boards of education and the Sterling Regional High School District Board of Education may be able to attain improved educational quality and efficiencies through consolidation or regionalization; and

WHEREAS, a formal study must be undertaken to accomplish this objective; and

WHEREAS, the Sterling Regional High School District Board of Education has agreed to be the lead entity in conducting this study and will submit the application for financial support for this study to DLGS on behalf of all participating units.

NOW, THEREFORE, BE IT RESOLVED by the Sterling Regional High School District Board of Education it shall apply for a LEAP Implementation Grant to support undertaking a feasibility study to explore the options for regionalization of the Sending District Boards of Education, either independently or with Sterling Regional High School District, and/or the consolidation and sharing of services by and among the Sending District Boards of Education and Sterling Regional High School District Board of Education, on behalf of itself, and on behalf of the Sending District Boards of Education.
